

## 7 INVOICE PROCESS



### Notes:

- The application fee is valid for 12 months. After this period, the vessel enters the system of 'Annual fees' (C). An annual fee is, independent from the execution of a survey, and will be invoiced yearly. The cost of the survey is included in the Annual fee (C). Travel and accommodation costs are invoiced per survey.
- After a 3 year certification period, the ship certificate will be renewed on the basis of the Annual fee (C).
- After a 3 year certification period, the office certificate will be renewed on the basis of the office audit fee (A).
