# Green Award Tariffs 2024

The Green Award Foundation has set its tariffs for 2024. This year we celebrate our 30th anniversary. Specially for this year, we have a reduced application fee for 2024, ranging from 10-30%. Below you find the tariffs per category. This overview is followed by an explanation about the additional costs and the flowchart of our invoice process.

## TARIFFS

# Green Award Tariffs 2024

## COSTS

### 1. Additional costs (D)

- For every office audit and survey following costs will be charged:
  - Air travel – costs based on business class
  - Car travel - € 0,50 per km or car rental costs
  - Travel time - € 116 per hour (maximum € 955 per day per person)
  - Accommodation costs
  - Miscellaneous (taxi, meals etc.)
- A surcharge of 5 % will be added based on travelling and accommodation expenses charged by third parties.
- If survey/inspection takes longer than 1 day (exempt travel time), there will be a surcharge of € 955 per day per person.
- For survey/section on Saturdays/Sundays and public holidays there will be a surcharge of € 955 per day per person.

### 2. Extra audit/survey<sup>1</sup>

If an extra survey is needed, there will be a charge of € 116 per man-hour with a maximum of € 955 per day per person.

### 3.Complaints<sup>2</sup>

In case of a complaint the complainant is to deposit € 1,500 for the costs of the investigation.

### 4.Miscellaneous

- Green Award flag € 75
- Green Award plaque € 100



## INVOICE PROCESS



### Notes:

- The application fee is valid for 12 months. After this period, the vessel enters the system of "Annual fees" (C). An annual fee is, independent from the execution of a survey, and will be invoiced yearly. The cost of the survey is included in the Annual fee (C). Travel and accommodation costs are invoiced per survey.
- After a 3-year certification period, the ship certificate will be renewed based on the Annual fee (C).
- After a 3-year certification period, the office certificate will be renewed based on the office Audit fee (A).
