# Tariffs 2025





The Green Award Foundation has set its tariffs for 2025. Below you find the tariffs per category. This overview is followed by an explanation about the additional costs and the flowchart of our invoice process. From 2025, the Application fee for the ships have been reduced continuing the 30th anniversary discount.

#### **TARIFFS**

All ship types below of above 400 gross tonnage (GT) are eligible for Green Award certification. Please refer to Annex I of the Green Award regulations in the <u>Seacure for Operations</u> for the detailed description of the ship types.

#### COSTS

#### 1. Additional Costs (D)

- For every office audit and survey following costs will be charged:
  - o Air travel costs based on business class
  - o Car travel €0,50 per km
  - o Travel time €119 per hour (maximum €979 per day per person)
  - o Accommodation costs
  - Miscellaneous (taxi, meals, etc.)
- A surcharge of 5% will be added based on travelling and accommodation expenses charged by third parties.
- If survey/inspection takes longer than 1 day (exempt travel time), there will be a surcharge of €979 per day per person.
- For survey/section on Saturday/Sundays and public holidays there will be a surcharge of € 979 per day per person.

### 2. Extra audit/survey<sup>1</sup>

If an extra survey is needed, there will be a charge of €119 per man-hour with a maximum of €979 per day per person.

#### 3. Complaints<sup>2</sup>

In case of a complaint, the complainant is to deposit €1.500 for the costs of the investigation.

#### 4. Miscellaneous



#### **INVOICE PROCESS**



#### Notes:

- The application fee is valid for 12 months. After this period, the vessel enters the system
  of "Annual fees" (C). An annual fee is, independent from the execution of a survey, and
  will be invoiced yearly. The cost of the survey is included in the Annual fee (C). Travel and
  accommodation costs are invoiced per survey.
- After a 3-year certification period, the ship certificate will be renewed based on the Annual fee (C).
- After a 3-year certification period, the office certificate will be renewed based on the office Audit fee (A).
